The Retired Members Association is sad to report the passing of Grahame Ellis. Grahame passed away overnight on Wednesday, 17TH November 2021. Grahame finally lost his battle with cancer; he had been having treatment over the past year. The retired mmebers Association will advise of the funeral details once they are known.

Grahame had been a member of the Retired Members Association for over eighteen years.

Grahame commenced with the PMG on the 2nd of December 1957. He was a 1958 Technician in Training. After his initial training, Grahame received an assignment to the Kempsey Division.

Bush Fire Season

Some of you may have recently seen a story on the **7.30** current affairs programme where the presenter travelled to the South Coast to catch up with the locals two years after the bush fires that caused much devastation. An unfortunate component to the story was to do with homeowners' insurance. We have all heard about people without no insurance on their properties. However, many people on the South Coast found themselves underinsured and were unaware they were in this circumstance. Two years later, many are staying in sheds and caravans, with the prospect of doing the same for years to come becuase they cannot afford the rebuilding costs.

We all know the insurance companies will increase their premiums (often by a double percentage figure) each year. The insurance companies attain their high premiums by increasing the insurance coverage, and arguably there is some price overcharging. Therefore, there is the temptation for you to decrease your coverage amount to lower your premium. However, there is the risk that your lower coverage value is far less than you will need to rebuild your home.

Remember, rebuilding will require the removal of building remains, new home constructions have higher specifications, there is the increasing cost of materials, and the shortage of tradespeople and hence higher labour costs.

If you consider your premium is too high, contact your insurance company and tell them their premium is too high. You may find them prepared to lower your premium without the need to reduce your coverage amount. With my insurer, I know I can speak to them on the phone, and they usually ask me a series of questions about the profile of my house, how many bedrooms, bathrooms, etc? They put this into a model along with your postcode and come up with the recommended coverage amount. If you are in doubt, I suggest you go through this exercise. It does not take long, and as the saying goes, it is better to be safe than sorry. The most complacent action you can take is to think it will never happen to me. Well, I must remind vou that one of our members lost his home in the Blue Mountains to bush fires about four or five years ago. There could well be other members who were in this circumstance.

Don't forget to clean out your gutters before the bush fires hit.


As I mentioned, the committee has worked well through what has been a challenging year. So again, I thank each committee member for their hard work and dedication.


Now, I take this opportunity to wish all members and their families a safe and happy festive season. Fingers crossed that 2022 will be a better year than what we have endured in 2021.

Bill "Bunny" Johnson




John Lane's mention of Frank Hyde in a past newsletter issue has prompted feedback from members.
